1. This Invitation for Initial Selection for Works (Design and Build) follows the General Procurement Notice published on the World Bank Website and the UN Development Business (UNDB) on February 3, 2022.
2. The Government of Liberia *has received* financing from the World Bank toward the cost of the Rural Economic Transformation Project (RETRAP) and intends to apply part of the proceeds toward payments under the contract for the Rehabilitation of the section of Road from Tappita to Toe Town under Design-Build and Transfer (DBT).
3. The Infrastructure Implementation Unit (IIU) of the Ministry of Public Works intends to initially select Applicants for Rehabilitation of the section of the Road from Tappita to Toe Town under Design-Build and Transfer (DBT). The length of the corridor is 40 km and is contiguous to the stretch of 100 km from Ganta to Tappita which is financed under the Southeastern Corridor Road Asset Management Project (SECRAMP) The road has several cross-drainage structures (culverts, bridges over streams and rivers). The works involve the development of a 2-lane highway with shoulders. The contract period is planned for three (3) years. The section of road to be rehabilitated is located in the northeastern part of Liberia. Applicants are expected to have the following minimum experience:
 - A minimum number of two (2) similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member management contractor, or subcontractor for at least the last 5 years starting from January 1, 2021, to January 1, 2017.
 - (I) DBT/ DBMOT/ DBMT/ OPRC contracts, each of minimum value of US\$30 million

(ii) A minimum design experience, using the above or other contracts, in at least two (2) contracts shall be demonstrated for the following key activities:

- Structural Concrete 20,000 m³
- Bituminous surfacing 80,000 m³
- Base 150,000. m³
- Sub-base 250,000 m³
- Subgrade 225,000 m³
- Fill material 100,000 m³
- Bridges at least 5 over 30m long

It is expected that the Request for Proposals will be made in October 2022.

4. Initial Selection will be conducted through the procedures as specified in the World Bank's Procurement Regulations for IPF Borrowers July 2016, Revised November 2017, *August 2018, and November 2020* ("Procurement Regulations"), and is open to all eligible Applicants as defined in the Procurement Regulations.
5. Interested eligible Applicants may obtain further information from the IIU at the address below during office hours from 9:00 am to 4:00 pm local time. A complete set of **Initial Selection** documents in English may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of Five Hundred US Dollars (US\$500.00).
